ARKANSAS VALLEY CONDUIT CONSTRUCTION UPDATE

Mr. Gordon Dillon updated the Board as follows: Work continues on the Arkansas Valley Conduit (AVC) under the 2022 contract awarded to WCA Construction LLC. In the latest phase of the AVC project, Global Underground installed about 5,000 feet of 30-inch HDPE pipe during the first week of April. Mr. Dillon had a short video of the installation and explained the process as the video plays.
