U.S. BUREAU OF RECLAMATION REPORT

Roy Vaughan presented a PowerPoint presentation reviewing the following:

Mr. Vaughan reported Mt. Elbert Conduit is currently moving 380 cfs. Reclamation is currently not releasing any Project water from Twin Lakes Reservoir, and plans on moving an additional 5,000 acrefeet from the upper reservoirs to Pueblo. Movement of water will be adjusted according to the forecast and customer needs.

STATE LEGISLATION UPDATE

Lee Miller reported the General Assembly has adjourned. The Board was provided a final update on legislation followed by the Colorado Water Congress State Affairs Committee. While there were some surprise vetoes by Governor Polis of legislation passed by the Democratic-controlled legislature, none of the vetoes involved water legislation.

With the session complete, focus turns to the Water Resources Review Committee (WRRC). The first meeting of the WRRC will be on August 21, 2019, at the Colorado Water Congress summer meeting in Steamboat Springs. As more information becomes available about agendas and other plans for the WRRC, the Board will be updated.

COLORADO RIVER ISSUES STATUS

Lee Miller reported the seven Basin states representatives signed the Drought Contingency Plan (DCP) agreements in a signing ceremony at Hoover Dam on May 20, 2019.

Both the State of Colorado and the Upper Colorado River Commission (UCRC) have begun steps necessary to implement the Demand Management Program (DMP). The Board was provided two memos from the CWCB: (1) a memo dated June 3, 2019 from CWCB Director Rebecca Mitchell regarding "Demand Management Investigation: The Path Forward" and (2) a memo dated June 10, 2019 regarding "Demand Management 2019 Work Plan – Update #1." The updated Work Plan includes a listing of the Work Groups membership. Lee Miller, Chris Woodka, and Board member Seth Clayton, as well as other representatives from District constituents, are all serving on one of the Work Groups.

The UCRC will hold a Demand Management Stakeholder Workshop in Salt Lake City of June 21, 2019, the day following the Board meeting. Information on that workshop was provided to the Board. Lee Miller will attend that Workshop on behalf of the District.

The midyear UCRC workshop and regular meetings will be held on Thursday, June 27 and Friday, June 28, 2019, respectively, at the Keystone Resort and Conference Center in Keystone, CO. Lee Miller will attend the meetings as an advisor to the Colorado Commissioner. The regular meeting on Friday is open to the public.
