PRESENTATION ITEMS:

FEDERAL LEGISLATION UPDATE

Ms. Christine Arbogast updated the Board:

News was received yesterday that the DOGE review of projects and programs at the Bureau of Reclamation has been completed and freeze on funding has been removed. The Arkansas Valley Conduit, will resume where we were when the freeze went into place a few weeks ago.

Negotiations continue between top appropriators on the FY '25 funding. The current Continuing Resolution runs out on March 14.

The Senate and House have both passed budget bills out of committee and the Senate is expected to vote today on the floor; the House will do so next week. The Senate is proceeding with a two-step budget reconciliation process, while the House is proceeding with one big bill. It is unknown how those differences will be resolved, but the speaker of House does not at this time have the votes to pass the bill that came out of committee.

Meanwhile, it is unknown when the Administration will release its FY '26 budget. It is usually released in the first week in February but that has slipped in the last four to five years.

On the nomination front, Andrea Travnicek has been nominated to serve as Assistant Secretary for Water and Science. She formerly served as a deputy in that office during the first Trump administration and she recently was the director of the North Dakota Department of Water Resources. NWRA has sent a letter of support for her nomination.

The Administration has nominated heads of the Bureau of Land Management and the Fish and Wildlife Service, and so a Reclamation nominee could come sooner than we thought.
