ACCEPTANCE OF 2015 COMPENSATION STUDY

Chairman of the Human Resources (HR) Committee Gary Bostrom, reported the HR Committee met on October 15, 2015 to review the Compensation Study that Susan Owens from Owens Group, Inc. had prepared.

Chairman Bostrom said that Mrs. Owens suggested to maintain competitive ranges, the District should continue the practice of annually monitoring average base salary structure adjustments within Colorado and the Water Resources industry and make structure adjustments accordingly. The District should also continue its practice of formally reviewing all positions prevailing market rates every three years, unless market indicators make a study advisable sooner for select positions.

Chairman Bostrom moved, seconded by Mr. Goodwin, the Board accept the 2015 Compensation Study, which the HR Committee has reviewed and approve a holiday bonus for the Executive Director of \$1,000. Motion unanimously carried.

Mr. Broderick said Mrs. Owens also generated what the salary ranges for 2016 would be with the consumer price index of 1.8 percent increase. He said the 2015 Compensation Study and 2016 salary ranges would be posted to the Board website for review.

2016 PROPOSED BUDGET AND RESOLUTION APPROVAL

Leann Noga reported the Board received the 2016 Proposed Budget on October 15, 2015 and the Public Hearing was held on November 19, 2015. Mrs. Noga recommended the approval of Resolution and Order No. 2015-01DF for the adoption of the 2016 Proposed Budget as presented, and authorize the Budget Officers to make any necessary adjustments to the stated mill levies and proposed budgeted amounts by December 15, 2015.

Mrs. Ortegon moved, seconded by Mr. Pruett, the Board approve Resolution and Order No. 2015-01DF for the adoption of the 2016 Proposed Budget as presented. Motion unanimously carried.

- There is currently 126,085 acre-feet of Project space in Pueblo Reservoir and 20,063 acre-feet of space in Turquoise and Twin Lakes Reservoirs.
- Project Reservoirs: Turquoise 104%; Twin Lakes 100%; Pueblo 136%
- Storage Capacity and Remaining Storage
