## FEDERAL LEGISLATION UPDATE

Ms. Christine Arbogast gave an update to the Board:

- 1. The shutdown is over, and activity renews on the appropriations process. We are still waiting for the energy and water bill in the Senate to be released, indicating funding for Reclamation and the AVC.
- 2. The appropriators are hoping to move two or three more bundled bills before the end of the year but certainly before the next continuing resolution expires on January 31.
- 3. I will be speaking next week with the staff of the Energy and Natural Resources Committee regarding movement of water-related bills including the Boebert-Hurd bill on AVC.

## Lake Powell vs Lake Mead Storage Patterns Last 10 Years

- Examines storage patterns of both lakes from 2015 to 2025.
- Highlights significant drops in water levels and implications for water supply.

## Lake Powell Inflow vs. Outflow

- Analyzes inflow and outflow data for Lake Powell from 2015 to 2025.
- Provides critical data on inflow and total release in cubic feet per second (CFS).

Mr. Gordon Dillon updated the Board on construction of the AVC:

- Construction
  - 1. Boone Reach 1
    - a. Close Out
  - 2. Boone Reach 2
    - a. Waiting for CDOT permit to bore under HWY 96
    - b. Installing fiber optic
  - 3. Injection Site Phase 1- Early 2027 completion (current schedule)
  - 4. Crowley Reach 1 Construction starts early 2027
- AVC 2025 Workplan through November
- 1. Design through Rocky Ford (SRF Package 1):
  - a. 60% submission with cost estimate complete
  - b. Starting negotiations for 60-100% design work
  - 2. SRF Loan Application was submitted November 5<sup>th</sup>
