AUTHORIZATION OF STIPULATION IN THE APPLICATION OF TRIVIEW METROPOLITAN DISTRICT. CASE NO. 22CW3004, WATER DIVISION 2

Mr. Peter Levish presented to the Board an action item recommending that the Board of Directors authorize Special Water Counsel to execute a stipulation with Triview Metropolitan District ("Triview") in Case No. 22CW3004, Water Division 2, consenting to entry of a decree that is no less restrictive on Triview and no less protective of the District's water rights and interests than the proposed decree dated May 24, 2024.

In Case No. 22CW3004, Triview seeks to change the entire water right for the Bale Ditch No. 1 (2.33 cfs) and the Bale Ditch No. 2 (a total of 2 cfs: 1 cfs owned by Triview, and 1 cfs owned by co-Applicants James and Diane Treat). The source of the Bale Ditch water right is the South Arkansas River near Salida, and Triview proposes to change these water rights from their historical irrigation use to municipal purposes within Triview's service area (near Monument Creek, north of Colorado Springs) or for use to meet return flow obligations. Triview seeks to store the water in Pueblo Reservoir, as well as Big Johnson and Stonewall Springs Reservoirs. Triview has entered into a long-term excess capacity contract with the Bureau of Reclamation to store 999 acre-feet in Pueblo Reservoir, for use outside of the District's boundaries. Triview proposes to replace historical return flows to downstream calling rights on the South Arkansas River and the Arkansas River with fully consumable water from the Bale Ditches, Triview's Denver Basin groundwater sources, and water decreed for replacement use from Triview's share ownership in the Fountain Mutual and Excelsior Ditches.

The District's objectives in Case No. 22CW3004 are to: (1) ensure that the proposed decree includes appropriate Standard Language terms for Triview's use of Fryingpan-Arkansas Project ("Project") facilities, such as Pueblo Reservoir; (2) ensure that all historic return flows are replaced in a manner that avoids injury to the District's rights and operations, including the District's exchange right on the South Arkansas River decreed in Case No. 97CW160, and VFMP flows at the Wellsville Gage; (3) ensure appropriate quantification of the changed water rights to avoid injury; and (4) ensure that the Water Court retains jurisdiction for an appropriate timeframe to evaluate injury that may result from Triview's proposed change. The District feels that these paragraphs sufficiently cover any concerns.

A copy of the Proposed Decree was provided to the Board.

Mr. Clayton moved, seconded by Mr. Pifher to authorize Special Water Counsel to enter a stipulation with Triview consenting to entry of a decree in Case No. 22CW3004 that is no less restrictive on Triview and no less protective of the District's water rights than the proposed decree dated May 24, 2024. Motion carried unanimously.

## STATE LEGISLATIVE UPDATE

Mr. Peter Levish updated the Board. The Water Resources and Agriculture Review Committee will meet on July 11, August 7, August 21, and September 18, 2024. We have not yet seen agendas for any of the upcoming meetings; however, the Colorado Water Congress (CWC) has solicited topics to share with the Committee for possible inclusion on the agendas. If there are specific topics you would like to be considered, please email those to Peter Levish at Peter@secwcd.com as soon as possible so that he can share them with CWC no later than the end of day, on June 21, 2024.

The Water Quality Control Division will be hosting a series of Dredge and Fill Stakeholder meetings on September 4, October 1, November 6, and December 4, 2024, to prepare for implementing the legislation passed during this last legislative session. District staff will participate in these meetings to the extent possible and useful to the District's projects.

A copy of the Colorado Water Congress Bill Status Sheet was provided to the Board.

#### COLORADO RIVER ISSUES

Mr. Lee Miller updated the Board first by stating, as part of the transition of duties:

- 1. Peter Levish will now be giving the State Legislature Update at the Board Meetings. Peter is getting more involved in areas that he needs to be in, under the direction of Lee Miller.
- 2. Mr. Lee Miller has stepped down as CWC Vice Chair for State Affairs

The Upper Division States (UDS) sent a letter to the Bureau of Reclamation (Reclamation) Commissioner on June 11, 2024 (UDS letter), regarding Reclamation's consideration of existing Colorado River Basin Project Act storage volume provisions. The UDS letter points out that the "Section 602(a)" storage volumes were not properly included in Reclamation's "no action alternative" in the National Environmental Policy Act (NEPA) analysis of post-2026 guidelines for operating Lakes Powell and Mead. The letter requested that the issue be properly addressed before continuing with the NEPA analysis. A copy of the UDS letter is attached. A copy of the letter was provided to the Board.

The Upper Colorado River Commission (UCRC) will meet on June 26, 2024, in Cheyenne, Wyoming. Topics will include the 2024 System Conservation Pilot Program, Demand Management Program, and hydrologic shortages in the UDS. Lee Miller will attend the UCRC meeting and the work session preceding the meeting as a member of the UCRC Legal Committee.

Representatives of the Colorado River District and Xcel Energy have made presentations throughout the state, including a presentation at the Arkansas Basin Roundtable meeting, in an effort to promote the "Shoshone Water Right Preservation" or the "Shoshone Permanency." Leann Noga (remotely) and Lee Miller attended a meeting at Xcel's offices in Denver last week with representatives from Reclamation, the State of Colorado and water users throughout the state

to begin discussion on terms and conditions for adding instream flow purposes to the Shoshone Power Plant Water Rights. The River District recently provided the District with a technical analysis on how the change of the Shoshone Water Rights to instream flow purposes would impact the Roaring Fork basin. District staff is reviewing this and other information.

The Colorado Water Congress's (CWC) special project covering the Endangered Species Project on the Colorado River and San Juan River (CRP) is experiencing transition, including the upcoming retirement of Tom Pitts. The CWC Executive Committee recently requested that all CWC special projects, at a minimum, elect a project Chair and Vice Chair, and consider the election of a project Treasurer, as needed. The CRP is a CWC special project, and thus, needs to begin the selection of officers. Due to the transition, there is a budget shortfall and the CWC will soon be asking sponsors of the CRP to help make up the shortfall. The CRP Executive Committee is also working on a set of questions to submit to the Water Acquisition Committee in regard to the Shoshone Water Rights.
