# AURORA WATER: WILD HORSE RESERVOIR PROJECT

### **ACTION ITEMS:**

PUEBLO URBAN RENEWAL AUTHORITY: NORTH ELIZABETH HOTEL RENEWAL AREA Mr. Jim Broderick began his action item by introducing Mr. Jerry Pacheco, Executive Director of The Pueblo Urban Renewal Authority, to familiarize him to the Board.

Mr. Broderick then went on to present his item, recommending the Board authorize the Executive Director to execute an agreement with the Pueblo Urban Renewal Authority to provide tax increment financing for an urban renewal project: North Elizabeth Hotel Urban Renewal Area.

It is anticipated that the generally applicable real and commercial personal property taxes from this project could generate between \$0 to \$7,022,058 (\$63,978 District) over the 25-year period assuming the objective of site remediation and building of a hotel. This project would reverse years of stagnant property tax revenue receipts within this area, and as shown in the impact Report these new property revenues would not be realized in the future without this investment in the project area.

This was brought before the Resource Engineering and Planning Committee for approval before coming to the Board.

A copy of the Impact Report and Agreement was provided to the Board.

Mr. Hamel moved, seconded by Mr. Colosimo, the Board authorize the Executive Director to execute an agreement with the Pueblo Urban Renewal Authority to provide tax increment financing for an urban renewal project: North Elizabeth Hotel Urban Renewal Area. Motion unanimously carried.

APPROVAL OF STIPULATION OF SPRING FALLS, LLC, CASE NO. 22CW3077, WATER DIVISION 5

Mr. Peter Levish presented an action item recommending that the Board authorize Special Water Counsel to execute a stipulation with Spring Falls, LLC ("Spring Falls") in Case No. 22CW3077 Water Division 5, consenting to entry of a decree that is no less restrictive on Spring Falls and no less protective of the District's water rights than the proposed decree dated October 19, 2023.

On September 15, 2022, the Board authorized Special Water Counsel to file a statement of opposition to Spring Falls' application for conditional underground and surface water rights, conditional storage rights, conditional appropriative right of exchange and a plan for augmentation in the Fryingpan River basin.

In Case No. 22CW3077, Spring Falls seeks conditional underground, surface, and storage water rights to operate a children's education and recreation camp, along with a plan for augmentation and conditional right of exchange on Spring Creek. Spring Creek is tributary to Lime Creek, which is tributary to the Fryingpan River upstream of Ruedi Reservoir. The District holds decreed conditional water rights for the Fryingpan-Arkansas Project ("Project") on Lime Creek and its tributaries, and the Project's water rights in the Fryingpan River drainage are subject to minimum stream flow requirements. Because Spring Falls' proposed conditional water rights may deplete the flows of the Fryingpan River and Lime Creek, Spring Falls' proposed plan for augmentation may reduce the amount of water available for Project diversions and may cause injury to the District's senior water rights. Spring Falls has applied for a water allotment contract from Basalt Water Conservancy District for augmentation water, including water stored in Ruedi Reservoir.

The Statement of Opposition was filed, the District received the Proposed Decree on October 19, 2023. The Proposed Decree provided by Spring Falls on October 19, 2023, includes appropriate terms to ensure that its augmentation plan replaces its depletions to Lime Creek and the Fryingpan River.

Wilson Water Group (WWG) has also reviewed the Spring Falls' preliminary engineering report and has confirmed it has no concerns about the engineering approach Spring Falls used to define its augmentation needs and replacements.

A copy of the proposed Decree was provided to the Board.

Mr. Clayton moved, seconded by Mr. Garcia, to authorize Special Water Counsel to enter a stipulation with Spring Falls consenting to entry of a decree in Case No. 22CW3077 that is no less restrictive on Spring Falls and no less protective of the District's water rights than the proposed decree dated October 19, 2023. Motion unanimously carried.

# INCLUSION OF LAND ANNEXED BY COLORADO SPRINGS

Mr. Markus presented an action item to the Board recommending approval of the inclusion of the annexation to the City of Colorado Springs into the Southeastern Colorado Water Conservancy District (District) with the standard terms and conditions. Once approved by the Board of Directors, staff will send the annexation to the Bureau of Reclamation (Reclamation) for assent. The District will submit the inclusion to the District Court for final decree. In the Resource and Engineering Planning Committee meeting, it was brought up that usually lands that are annexed are contiguous, the Land just west of this, was previously approved for Annexations by the Board a few months ago.

There are three methods of including lands into the District:

- 1. Annexation by a town or city located in the District.
- 2. Petition of the property owners.
- 3. Vote of the property owners.

All three of these methods require assent from the Secretary of Interior, for which Reclamation requires a National Environmental Policy Act (NEPA) review of the lands to be included in the District boundaries. Once the Board approves the inclusion by Resolution, then Secretarial Assent by Reclamation is requested. The inclusion is submitted to the District Court for a decree including the lands within the District. The Application of Assent has been submitted to the District and will be forwarded to Reclamation for the property.

A copy of the maps, and the Resolution were provided to the Board.

Mr. Edelmann moved, seconded by Mr. Garcia, that the Board approve, by Resolution, the inclusion of Colorado Centre Addition No. 3 annexed by Colorado Springs subject to the following terms and conditions:

- 1. Approval of these inclusions into the Southeastern Colorado Water Conservancy District will not increase the amount of Fryingpan-Arkansas Project water available to the city. Any Fryingpan-Arkansas Project water used on these included lands will need to come from the water allocated to the city through Fryingpan-Arkansas Project water allocations made pursuant to the District's Allocation Principles and Policies; and
- 2. Any use of Fryingpan-Arkansas Project water on the included lands is subject to the decrees for the Fryingpan-Arkansas Project, and to all lawful rules, regulations, principles, policies, and contractual obligations of the District; and
- 3. The annexed lands will be subject to ad valorem taxes levied by the District as any other similarly situated lands in the District at the time of this inclusion; and
- 4. Prior to the District filing a petition for District Court approval of this inclusion, the Municipality, and/or owner(s) of the annexed lands shall have paid all the costs charged by the United States in connection with the contracting officer's assent to this inclusion.

  Motion unanimously carried.

# STATE LEGISLATIVE UPDATE

Mr. Broderick updated the Board stating the Water Resources and Agriculture Review Committee (WRARC) met on October 31, 2023, and referred several bills to the Legislative Council of interest to the District for consideration during the next legislative session.

- **Bill 2** revises the Water Conservancy District Act to include several new authorities, including authorizing Districts to participate in a plan for augmentation; contract with water users outside the District for provision of services; exercise certain powers regarding the control, delivery, use and distribution of water; establish a water activity enterprise; and sell, lease, or otherwise dispose of the use of water or capacity in works by contract.
- **Bill 6** prohibits local governments and unit owners' associations of common interest communities from allowing the installation, planting, or placement of "nonfunctional turf," artificial turf, or an invasive plant species on any commercial, institutional, or industrial property.
- **Bill 9** authorizes a study of "Green Infrastructure" for water quality management

Notably, the WRARC failed to garner the necessary seven votes to recommend **Bill 8**, which was a bill on conservation of water rights, derived from a 2021 Arizona statute. Despite this failure we expect Senator Dylan Roberts to introduce this bill during the regular session.

# **COLORADO RIVER ISSUES**

Mr. Broderick updated the Board with the SB23-295 Colorado River Drought Task Force (CRDTF) met on November 9, 2023, in Glenwood Springs and meeting again on November 16, 2023, overlapping with the Board meeting. Lee Miller is the District's representative to the CRDTF; Jim Broderick is the alternate. Lee will be attending the meetings and will provide an update during the Board meeting, time permitting. The meeting will be livestreamed on the CRDTF website: <a href="mailto:crdroughttaskforce.com">crdroughttaskforce.com</a>.

The final scheduled meeting is December 7, 2023. The deadline for the Committee to provide recommendations to the Legislature is December 15, 2023.

The Upper Colorado River Commission (UCRC) will hold a work session on November 28, 2023, in Denver. Lee will attend this meeting as a member of the UCRC Legal Committee.
