RESOURCE AND ENGINEERING PLANNING COMMITTEE MINUTES

June 1, 2017

A meeting of the Resource and Engineering Planning Committee was held on Thursday, June 01, 2017 at 10:00 a.m. at the District Office, 31717 United Avenue, Pueblo, Colorado.

Chairwoman Vera Ortegon announced a quorum was present.

APPROVAL OF MINUTES:

Chairwoman Vera Ortegon confirmed that members of the Committee received their copy of the April 13, 2017 minutes, and if there were any corrections or additions. Hearing none, Tom Goodwin moved, seconded by Gibson Hazard, to approve the minutes. Motion carried unanimously.

PRESENTATIONS:

PUEBLO DAM HYDROELECTRIC PROJECT UPDATE

Kevin Meador updated the Committee on the Pueblo Dam Hydroelectric Project as it continues to progress towards a start of construction by the fall of 2017. There were several critical activities completed in March and April which included finalization of a Power Purchase Agreement (PPA) with the City of Fountain and draft of Construction and Turbine Supply contracts with Mountain States Hydro, LLC. However, remaining activities include a final PPA with Colorado Springs Utilities/Fort Carson and the final Construction and Turbine Supply contracts.

Mr. Meador also reported that the Construction and Turbine Supply contracts are anticipated to be ready for final Board review in June. Colorado Springs Utilities anticipates having a final draft PPA ready for our legal review sometime in June. They anticipate submitting the final PPA to their Utilities Board and City Council for final approval in August 2017. Once the Power Purchase Agreements are executed, the Board can execute the Colorado Water Conservation Board loan contract, the final Lease of Power Privilege, and the Construction and Turbine Supply contracts. A notice to proceed will be issued to Mountain States Hydro, LLC at that time and construction can start. An April or May commissioning is anticipated in 2018 based on completion of the remaining activities.

The inclusions add 1,089.86 acres to the District and will not require any increase in allocation of water. These parcels have been reviewed by the Bureau of Reclamation for assent under a combination of the new administrative process and the old assent process to bring the District's boundaries to current.

Tom Goodwin moved, seconded by Curtis Mitchell, to recommend Board approval by individual Resolutions, the inclusion of twenty-six parcels annexed by the City of Colorado Springs subject to the following terms and conditions:

- Approval of these inclusions into the Southeastern Colorado Water Conservancy
 District will not increase the amount of Fryingpan-Arkansas Project water available
 to the City of Colorado Springs. Any Fryingpan-Arkansas Project water used on these
 included lands will need to come from the water allocated to the City of Colorado
 Springs through Fryingpan-Arkansas Project water allocations made pursuant to the
 District's Allocation Principles and Policies; and
- 2. Any use of Fryingpan-Arkansas Project water on the included lands is subject to the decrees for the Fryingpan-Arkansas Project, and to all lawful rules, regulations, principles, policies, and contractual obligations of the District; and
- 3. The annexed lands will be subject to ad valorem taxes levied by the District as any other similarly situated lands in the District at the time of this inclusion; and
- 4. Prior to the District filing a petition for District Court approval of this inclusion, the Municipality, and/or owner(s) of the annexed lands shall have paid all the costs charged by the United States in connection with the contracting officer's assent to this inclusion.
